

IMPORTANT CHINA TRIP INFORMATION

A non-refundable registration fee of \$200 per person is required and due at the time you register, but no later than August 1, 2009. This will be deducted from your total tour fare, the balance due no later than September 1, 2009.

An invaluable Pre-Tour Briefing for all travelers will be held on Tuesday, April 28, 2009 at Logsdon's at the Airport in Santa Paula from 5:30 pm – 7:30 pm. Santa Paula residents from last year's tour will be on hand to answer your questions. Mr. Leo Liu, President of Citlinc International, our tour operator, will also be available for your questions and familiarize you with the details of the trip, including tipping, luggage, customs, restrooms, etc.

Securing or updating your passport is your responsibility, and you must also take care of the required visa yourself. However, if you wish Citlinc International to handle the visa application (available on this website), you will need to provide them with your passport, a signed visa application form, two passport photos and \$145, per person, before October 1, 2009. Passports will be securely held for you until departure, or returned if requested, usually within 10 working days.
